THE TERMINAL SHOULD NOT BE SOLD OR LENT TO OTHERS WITHOUT THE PRIOR APPROVAL OF THE TELECOMMUNICATION AUTHORITIES INSPECTION OFFICE.

KEEP THE OWNERSHIP AND PERMISSION DOCUMENT TOGETHER WITH THE INMARSAT TERMINAL.

IF THERE IS ANY DISCREPANCY BETWEEN THE INFORMATION GIVEN HERE AND THE DATA ON THE TERMINAL PLEASE LET US KNOW AS SOON AS POSSIBLE.

SINCE THE TERMINAL IS GOING TO BE USED ABROAD MAKE SURE TO OBTAIN THE NECESSARY PERMISSION FROM THE AUTHORITIES IN ERITREA.
